




What are the ISO Net Zero Guidelines?

- A core reference text for credible net zero action to bring clarity to what good looks like
- Draws on the existing landscape of major net zero standards and initiatives
- Can be used by any organization in any jurisdiction
- Aimed to support national, regional, city and individual organizations to accelerate their net zero action





Why were the ISO Net Zero Guidelines developed?



Greenwashing and net zero integrity

	The UN called for greater action on the problem of 'greenwashing' in climate
	action and appointed a High-Level Expert Group to investigate this.



In the absence of a clear framework of standards and regulation for net zero, misleading and inaccurate claims have become widespread.



The UN published its *Integrity Matters* report at COP27 which set out recommendations for what must be done to restore integrity to net zero




The ISO Net Zero Guidelines is not just about bringing clarity to net zero action, but also helping to bring clarity to what it is not.

What do the ISO Net Zero Guidelines say? Key topics

Residual emissions Only the emissions remaining (5-10%) after deep emissions reductions are completed can be counterbalanced using offsets Fair share Those with greater historical responsibility and resources should make a proportionately greater contribution and support others to take action.

Nature and biodiversity Mitigation actions should take into account the need to preserve or enhance ecosystems and biodiversity.

Net zero claims To claim net zero, only residual emissions should remain, and these should be counterbalanced by removals. Avoided emissions Avoided emissions cannot be counted towards your net zero target. Organizations should act as solution providers to others. Reporting

Leadership should be directly accountable for monitoring and reporting processes. Reporting should be at least annual, include what offsets were used and disclose limitations of data.
